1. Apologies for Absence

Apologies for absence were received from Professor Timothy Dafforn, Miss Abbie Hutty and Sir Julian Young.

2. Conflicts of Interest

No conflicts of interest were declared.

3. Minutes

The Minutes of the meeting held on 11 November 2022 (T(22)M8) were <u>approved</u> and <u>signed</u> as a correct record.

4. Chief Executive and Secretary

- 4.1. The President made a report to the Board on the recruitment process for the Chief Executive and Secretary of the IET on behalf of the Recruitment Panel.
- 4.2. He reported that the Panel had made a unanimous recommendation to the Board to appoint Mr Ed Almond BSc MSc MBA FCA FIET as Chief Executive and Secretary.
- 4.3. The Board <u>agreed</u> unanimously to appoint Mr Almond as Chief Executive and Secretary.

5. Ofgual Statement of Compliance

- 5.1. The Board of Trustees <u>noted</u> that as an approved End Point Assessment Organisation for a selection of engineering apprenticeship standards, the IET had been recognised by Ofqual from 1 January 2022. Ofqual required the IET to submit an annual statement demonstrating continuing compliance with the General Conditions of Regulation, which should be approved by the Board of Trustees and signed by the President (T(22)107).
- 5.2. The Board <u>approved</u> the annual statement for 2022 and <u>agreed</u> that it should be signed by the President and submitted to Ofqual.

6. Feedback on Board Meeting

The President invited Trustees to give feedback on the Board of Trustees meeting.

7. Classification of Board Papers

- 7.1. The Board <u>noted</u> that one paper that had been considered at the meeting was Private and Confidential. The Private and Confidential papers had been so-classified because they contained:

- 7.1.4. legal advice or Counsel's opinion, or were otherwise covered by legal professional privilege or concerned active legal proceedings;
- 7.1.5. information considered confidential to a third party relationship, or which could be used externally to create legal challenge, reputational risk or commercial advantage.
